Center for Legal Resources (CRJ) is a non-governmental organization, founded in 1998 by the Open Society Foundation (currently, the Soros Foundation), acting for the creation and operation of a legal and institutional framework to ensure the respect for human rights and equal opportunities and free access to a fair act of justice. CRJ has two strategic directions - respecting human rights and promoting the rule of law. CRJ undertakes activities such as monitoring and research, advocacy, training, strategic litigation and institutional capacity building.

The National Agency of Civil Servants (NACS) was founded through the Law No. 188/1999 on the Civil Servants Statute and is subordinated to the Ministry of Regional Development and Public Administration being a public institution — a specialized body of central public administration, with legal personality. NACS is the originator of the Civil Servants' Code of Conduct, respectively Law no. 7/2004 republished and the institution that entered into the Romanian administrative system the `position` of ethics counselor and pursued the creation of a database of people responsible for ethics counseling in public institutions/ authorities.

Conference theme

The impact of public administration in day to day life of citizens and communities is increasingly greater in terms of both public affairs and budgetary management. The power spending community resources and influence the lives of others means at the same time a great responsibility – the responsibility to act morally (with integrity) and to ensure effective spending of resources. This means, including not to corrupt and not to let yourself be corrupted, but it also means openness to dialogue, to an internal climate of trust and cooperation, to internal procedures to ensure ethics cuonseling. Taking this into account, in the last 20 years, the public sector has developed legal rules or internal policies, procedures and organizational tools to ensure an organizational integrity and a responsible leadership. Public organizations have adopted and applied ethics codes, procedures regarding conflicts of interests, whistleblowing, gifts declaring and other measures to prevent corruption.

The conderence aims at challenging representatives of the public sector in Romania and in other European countries to discuss the experience and good practices on ethics systems, ethics problems and solutions/ working tool developed to tackle those challenges.
