In 2011 she was appointed by the European Commission as one of the 17 members of the Expert Group on Corruption. Between 2005 and 2007 she served as Director in the Romanian Ministry of Justice responsible the anticorruption policy. She drafted and advocated for the adoption of key anticorruption legislation, designed awareness programs and worked on reforming of the Public Prosecutors Office.

She also undertook very important representation functions such as: head of delegation and bureau member in GRECO, high representative to SPAI and SPOC, Romanian representative to the OECD Anticorruption Network and UN global forums on corruption and organized crime, member of the UNDP Anticorruption Practitioners Network.
