Today, May 11, took place the first meeting of the Diversity Charter Board from Romania at the NACS headquarters, as an activity within the project I.D.E.A.S.—Inclusion.Diversity.Equality.Awareness.Success. ((Launching Diversity Charters in Slovenia, Croatia and Romania), project financed by the European Commission, DG Justice and Consumers and implemented by the Company for Training and Employment of People with Disabilities from Slovenia, with partners from private and public sector from Romania, Slovenia and Croatia.

The National Agency of Civil Servants is one of the Romanian partners, together with the association Assistance and Programs for Sustainable Development – Agenda 21 and the foundation Forum for International Communications.

The council is formed by specialists in the field, representatives of the academia, the public and private sector, the non-governmental organizations and the trade unions (Michelin Central Europe, PUBLISIND Federation, the National Council against Discrimination, the Renault Romania Group, the Romanian Commercial Bank, the National Association of Human Resources Specialists, the National Agency for Equality of Chances between Women and Men, Carrefour Romania, the National School for Political and Administrative Studies and the Department for Interethnic Relations).

The Council has an advisory role throughout the project implementation period, being involved in the development and the implementation of the Diversity Charter from Romania by providing feed-back on the Charter proposal and other support materials, attending work meetings and events.
